## **Electronics Recycling Expands**

In early August, Governor Quinn signed a new electronic waste recycling law that may double Illinois' annual recycling goal.

Since the first manufacturer responsibility law took effect in 2010, recycling jobs in Illinois have tripled while the cost to consumers and local governments has dropped. In Will County alone, the County's cost to pro-

vide drop-off sites to residents has dropped \$100,000 from its record high, while the number of permanent sites has increased and we have added free front-door service.

This new law expands the list of items **banned from Illinois landfills on January 1, 2012**, from computers, monitors, printers and TVs to all electronic keyboards, fax machines, video/DVD recorders, CD and MP3 players, video/DVD players, video game consoles/players, small scale servers, scanners, electronic mice, digital converter boxes, cable receivers and satellite receivers. This



will increase jobs in the electronic recycling industry, decrease the materials sent to landfills and increase recovery of metals, plastic and other resources.

According to the Consumer Electronics Association (CEA), Americans now own approximately 24 electronic products per household. No longer must these be placed in the garbage or held onto for special

annual collections. Illinois is now poised to have one of the highest electronic recycling goals in the country and easily accessible means to achieve the goals!

Homer Glen and Homer Township just opened Will County's 13th permanent electronic drop-off. Our Front-Door Electronic Collection Service is about to expand to our southern border. ### **Vermicomposting Program to Continue**

Will County was happy that several schools requested the worm bins offered in the 2010-2011 school year by Joliet/ Will County Project Pride. Although Project Pride is no longer offering such composting bins, we have decided to continue the offer as a grant program through our department.

We were especially happy to receive a PowerPoint presentation from Godley Park District showing how worm composting can be used to fulfill a wide range of Illinois learning standards. Find the application at www.willcountygreen.com (scroll to the bottom of the page).

The grant will consist of personal delivery and brief instruction on:

- One ready-to-start vermicomposting bin
- One pound of red wiggler worms and bin bedding
- One vermicomposting book
- Access to a teacher with vermicomposting experience



In addition, participating teachers will be expected to complete periodic questionnaires and evaluations during the program.

At this time, Will County is providing one worm bin per school. If this program results in requests for enough bins to cover all classrooms in the same grade, it may be considered on a case-by-case basis. Any school that received a bin from Project Pride last year, is eligible to receive a bin under this newly established program.

#### **Complete 4 Earth Tasks:**

**Recycle Paper** and one additional material (ink cartridges, cans, bottles, plastic bags, etc.) **Use Both Sides** of photocopies or loose leaf paper; institute a double-sided policy. **Invite Will County** to your school for a presentation to one grade level or environmental group.

- e Will County to your school for a presentation to one grade level or environmental group.
- Students and faculty become environmental ambassadors to the remainder of the school.
- Follow-up report submitted to Will County related to information presented.

### Perform Two Activities of Your Choice involving one grade level or school club by May 1, 2012.

- Host a collection event to save landfill space and give items a new purpose (shoes, clothing, books, etc.) Schools may donate several bags to the Will County Textile Collection in May.
- Start an environmental club (meet at least monthly to discuss environmental topics);
- Start composting organic food scraps at school (using outdoor compost bin or classroom vermicomposting bin);
- Perform at least 2 waste-free lunch days during the school year;
- Host a recycled art fair to showcase student projects;
- Become a Lights4Learning school;
- Entire school uses natural lighting one hour a month, eliminating overhead lights (Earth Hour);

Presentations will be a minimum of 30 minutes and a maximum of 45 minutes. If multiple presentations are in the same day, the representative will need 15 minutes between classes for set-up/moving. Smaller groups are far more effective than large assemblies. We prefer to give several presentations in a school to groups with fewer than 40 students. In some buildings, this can mean that the presentations will be spread over two days.

During the 2011-2012 school year, the presentations will focus on energy conservation and alternate forms of energy, in addition to recycling.
